New requirements: payment of taxes and fees to the budget with a structured purpose of payment

Effective from **01.07.2023** all the tax payments and the payments to the budget payable by the Banks' Customers to the accounts of the State Tax Service and the State Customs Service opened with the State Treasury Service



a) will be received in a new format exclusively, with **STRUCTURED PURPOSE OF PAYMENT**,
b) During the transition period, which lasts until **01.12.2023**, such payments will be accepted in the current format (without the structured purpose).

All tax payments and payments to the budget are subdivided into 4 types:

1

Payments with the indication of the payment type code

2

Payments to the single account, without the payment type code and without the indication of the area to which funds are directed

3

Payments to the single account, without the payment type code and with the indication of the area to which funds are directed

4

Payments for the state-owned property lease

Important changes and requirements of the State Tax Service of Ukraine, State Customs Service starting from 01.12.2023

Starting from **01.12.2023** all tax payments, payments to the budget and other payments made to the accounts with the State Treasury with MFO "899998" (NBU ID code) – **shall be generated only in the new format with the structured purpose of payment, i.e. via the section "TO THE BUDGET"**

Attention!

According to the requirements of the State Tax Service of Ukraine, State Customs Service starting from 01.12.2023, if the payment to the accounts with the State Treasury with MFO "899998" is generated without the structured purpose:

- A) The Bank will not allow the Customer to generate such payment in the accounts remote servicing systems, by making the respective configurations and displaying the message of "prohibiting" nature,
- B) The Bank will not be able to process and send the respective payment according to its purpose,
- C) Payments to the accounts with MFO "899998" without the structured purpose that are DENIED by the State Treasury WILL NOT BE successfully credited to the recipient, and such payments will be returned.

Attention!

Starting from 01.12.2023 **you can pay taxes and make payments to the budget** via Raiffeisen Business Online (BIFIT) **only for yourself or your company**. If you need to pay taxes and duties for your subsidiaries you should fill in the information specifically for your subsidiary as a taxpayer in the section "Actual payer". You can carry out the respective payment via the branch, by submitting the payment instruction on paper medium according to new full form. The payment will be executed according to the Bank's tariffs for the payments on paper media.

Payment to the budget (4): for the state-owned property lease (LE)

Screen of the Payer-Legal entity

All fields are mandatory:

1. Additional information of the record – Payer fills in the information (the components of the said information are separated with ";" without blanks) regarding funds transfer.

Payer (lessee) – legal entity

1. tax code of the state enterprise with which an agreement on the state property lease is concluded (asset holder);
2. tax code of the business company with which the agreement on the state property lease is concluded (lessee);
3. Lease agreement number;
4. Lease agreement date;
5. Tax code of the privatization authority with which the lease agreement is approved;
6. Digit-attribute of lease payment type (possible values: 1 – lease pay, 2 – penalty, 3 – advance payment, security deposit).

Clarifications regarding the procedure for generation of payments of the type "administrative services", "fines for the violation of the traffic rules" etc., starting from 01.12.2023



Starting from 01.12.2023, if the Customer wants to make a payment for various "administrative services", fines for the traffic rules violation etc. (i.e. payments of "non-tax" nature) to the account with the State Treasury with MFO "899998":

- According to the requirements of the NBU and the State Treasury, the respective payment should be also generated in the new format with the structured purpose of payment.

Attention

Payment for all administrative services and payment of fines to the accounts with the State Treasury with MFO "899998" – SHOULD be also generated in accounts remote servicing systems – with the structured purpose.

Recommendations:

Raiffeisen Business Online (Bifit)	Select PAYMENT TO THE BUDGET/ Type-2 "To single account (without the payment type code and without the indication of the area to which funds are directed). Fine for the violation
of the traffic rules:

- Payment of the fine for parking
- Payment of the fine for the violation of the traffic rules according to the protocol

Clarifications regarding the payment of taxes and making payments to the budget for another person or organization, i.e. for another “actual payer”

There are cases, when the Customer needs to pay a tax/make a payment to the budget/other payments– not for the Customer itself, but for another person, i.e. another “Actual payer”:

- in Raiffeisen Business Online payment of taxes /making payments to the budget/ other payments– is implemented only if the Customer-Payer makes payments under its own obligations.

Payment for another actual payer in Raiffeisen Business Online – **IS NOT AVAILABLE (the functionality is being developed).**

The customer has the possibility to pay taxes/make other payments “for another actual payer”- at the Bank’s branch:






- a) Payment with cash in the cash desk of the branch, or
- b) With the execution of the extended payment instruction, using the full template (paper-based).

The payment will be executed according to the Bank’s tariffs for the payments on paper media.
