1. Import of payments in UAH

In Raiffeisen Business Online System, the user can import documents such as payment instructions in national currency. You can import files in the following formats:

- IBIS (CP-866);
- IBank2UA (CP-1251);
- XML (1, 2);
- CSV;
- Profix (DBF).

Requirements to the file structure depending on the format are described in subclauses 1.2.-1.6.

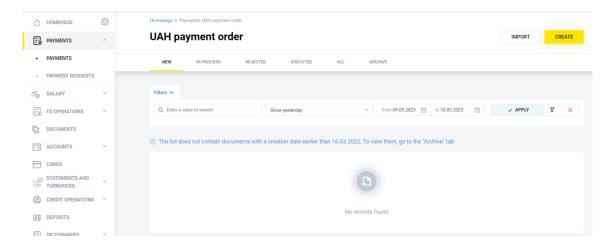
1.1. Import of payment instructions in national currency

To import payment instructions, go to the menu section "Payments" - > "Payments" and press

IMPORT



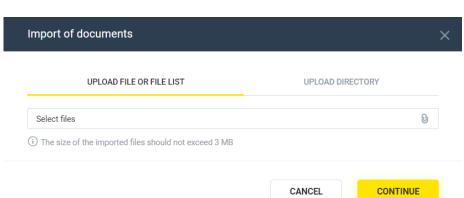




In the form that opens, you can import documents:

- By importing a single file or several files from a directory;
- By importing a directory that can contain several files.

To cancel the import of documents, press



CANCEL

To import, select the tab:

- · "Upload file or list of files", or
- "Upload a directory",

press the button and select the required file/several files from the directory or directory with files, press the button. The System will perform the process of reading and checking for compliance with the format and structure of each file, as well as validating each individual document in the file.

Based on the results of file processing, the System will generate a report with the import results, which will indicate the number of successfully imported files and the number of files containing an error.

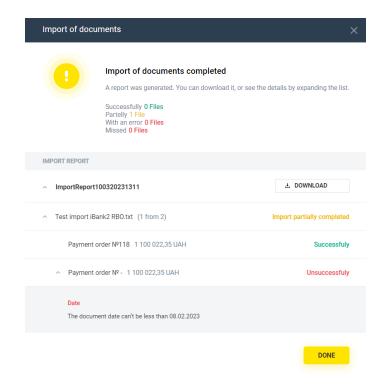
To view the details of the report on the import results of each individual document in the file, expand the list

- on the form or download the report to your device by pressing

 Leading file impart statuses are possible.
 - The following file import statuses are possible:
 - Import completed successfully the file structure meets the requirements (see 1.2. -1.6.), all documents in the file were validated without errors;
 - Import completed partially the file structure meets the requirements (see 1.2. -1.6.), with at least one document in the file being validated without errors and at least one with an error;
 - Import failed the file structure meets the requirements (see 1.2. 1.6.), all documents in the file have been validated with an error;
 - File skipped the file structure does not meet the requirements (see 1.2. 1.6.).







To complete, press or DONE

As a result, for all documents of the imported file or files, or for all files of the imported directory, with the import status "Successul", payment instructions in the status "New" will be created in the System.

1.2. File requirements for importing in IBIS (CP-866)

Files for importing payment instructions in IBIS format are text files with any extension in CP-866 encoding. These files must meet the following requirements:

- The file name must be in the format RddNNNN, where
 - o R(r) the Latin letter "R" or "r",
 - dd date of creation of the document (values from 01 to 31 inclusive). The date of creation may not coincide with the date specified in the file name,
 - NNNN any sequence of digits from 4 to 10 characters inclusive. It is required in the name;
- One file may contain several payment instructions. Each subsequent document must follow the specified structure and start on a new line;
- Each line must consist of fields separated by a "•" character (ASCII-code 250);
- Each parameter has a specific sequence number in the structure used in the format description. The numbering starts with "0" the serial number of the service field;
- Optional fields may be left blank. In this case, the parameter separator remains in the structure, then two or more separators will follow in a row in the line (exception: if parameters 18 and 19 are absent at the same time, the separators of these parameters may also be absent).

An example of an import file with three payment instructions in UAH is shown below:

1.3. File requirements for importing in iBank (CP-1251)

Files for importing payment instructions in iBank2UA (CP-1251) format – text files with any extension in CP-1251 encoding. These files must meet the following requirements:

- One file may contain both one and several payment instructions separated by a blank line;
- Regardless of the number of documents in the file, the Content-Type=doc/ua_payment line must be
 present before the first record, followed by an empty line;
- Each line must consist of fields separated by a new line;
- Optional fields may be left blank:
 - o the value and header of the field are absent,
 - o the field title is present, but there is no value.

An example of an import file with two payment instructions in UAH is shown below:

1.4. File requirements for importing in XML

1.4.1. File requirements for importing in XML (1)

Files for importing payment instructions in XML format – text files with the *.xml extension in any encoding. These files must meet the following requirements:

- One file may contain several payment instructions separated by the following tags:
 - Payment_info> tag to indicate the beginning of the document,
 - </Payment_info> tag to indicate the end of the document;
- Information about the encoding should be contained in the declaration of the xml file;
- Fields must be separated according to the rules of XML file formation;
- Optional fields may be left blank:
 - o the value and header of the field are missing,
 - o the field header is present, but there is no value.

Example 1 of an import file with a hryvnia payment instruction is shown below:

1.4.2. File requirements for importing in XML (2)

Files for importing payment instructions in XML format (2) - text files with the *.xml extension in any encoding. These files must meet the following requirements:

- One file may contain several payment instructions separated by the following tags:
 - o <RETURN> tag to mark the beginning of the document,
 - </RETURN> tag to indicate the end of the document;
- Information about the encoding should be contained in the declaration of the xml file;
- Fields must be separated according to the rules of XML file formation;
- Optional fields may be left blank:
 - the value and header of the field are missing,
 - o the field header is present, but there is no value.

- One file can contain several payment instructions. Each subsequent document must follow the specified structure and start on a new line;
- Each line must consist of fields separated by a ";" character;
- Each field has a specific sequence number in the structure used in the format description. The numbering starts with "1" the serial number of the service field;
- Optional fields may be left blank. In this case, empty parameter values will be listed with separators;
- Import is possible:
 - o with parameter values with headers,
 - o with parameter values without headers, written through a separator.

3.8. Structure of the export file in CSV

CSV export files are text files with the extension *.csv in the CP-1251 encoding. These files must meet the following requirements:

- Each transaction follows the specified structure and starts on a new line;
- Each line consists of fields separated by a ";" character;
- The file contains field names;
- Each field has a specific sequence number in the structure used in the format description. The numbering starts with "1" the serial number of the service field;
- Optional fields may be left blank. In this case, empty parameter values will be listed with separators;





- Fields containing a character that is used in the format as a separator are delimited at the beginning and end by double quotes;
- Fields containing double quotes are delimited at the beginning and end by double quotes, and the quotes themselves are additionally enclosed in double quotes.

4.1. Import of foreign currency payments

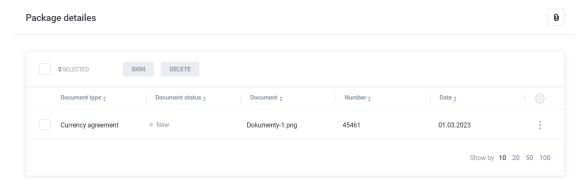
In order for the payment order to be sent to the Bank for processing, the application and all attached documents must be signed by all signature groups.

If not all attached documents have been signed by all required signature groups, they can be signed on the

"DOCUMENT PACKAGE" tab using the function On this attachment in the quick actions menu for this attachment





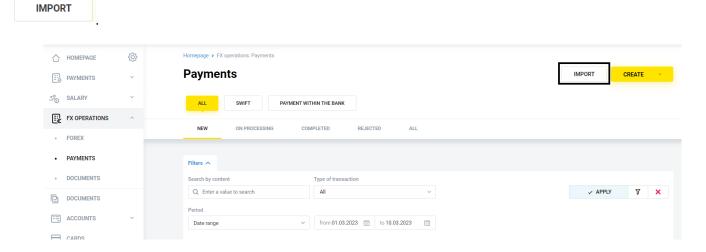


In Raiffeisen Business Online System, users can import foreign currency payment instructions from outside the bank. You can import files of the following formats:

- TXT;
- XML;
- CSV.

Requirements to the file structure depending on the format are described below.

To import payment instructions in currency, go to the menu section "Currency transactions" -> "Payments" and press



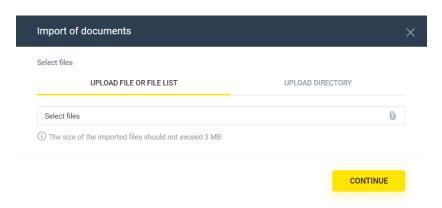




In the form that opens, you can import currency instructions:

- By importing a single file or several files from a directory;
- By importing a directory that may contain several files.

To cancel the import of documents, press



To import, select the tab:

- "Upload file or list of files", or
- "Upload a directory",

press the button and select the required file/several files from the directory or directory with files, press. The System will perform the process of reading and checking for compliance with the format and structure of each file, as well as validating each individual document in the file.

After processing the files, the System will generate a report with the import results, which will indicate the number of successfully imported files and the number of files containing an error.

To view the details of the report on the import results of each individual document in the file, expand the list on

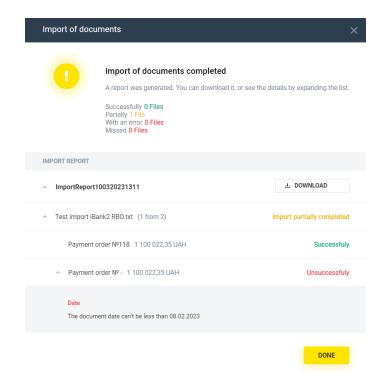
the form or download the report to your device by pressing

The following file import statuses are possible:

- Import completed successfully the file structure meets the requirements, all documents in the file were validated without errors;
- Import is partially completed the file structure meets the requirements, with at least one document in the file being validated without errors and at least one with an error;
- Import of documents is complete the file structure meets the requirements, all documents in the file have been validated with an error;
- File skipped the file structure does not meet the requirements.









As a result, for all documents of the imported file or files, or for all files of the imported directory, with the import status "Successful", payment instructions in the status "New" will be created in the System.

4.2. File requirements for importing in TXT

- TXT files for importing payment orders are text files with any extension in CP-1251 (Windows) encoding.
 A file of this format can have any name and extension.
- One file may contain several payment instructions. Each subsequent document must follow the specified structure and be separated from the previous document by a blank line;
- Regardless of the number of documents in the file, the Content-Type=doc/ua_payment line must be
 present before the first record, followed by an empty line;
- Each line must consist of fields separated by a new line;
- Optional fields may be left blank.

4.3. File requirements for importing in CSV

- A CSV file can have any name when imported.
- One file can contain several payment instructions. Each subsequent document must follow the specified structure and start on a new line;
- Each line must consist of fields separated by a ";" character;
- Each field has a specific sequence number in the structure used in the format description. The numbering starts with "1" the serial number of the service field;
- Optional fields may be left blank. In this case, empty parameter values will be listed with separators;
- Import is possible:
 - o with parameter values with headers,
 - o with parameter values without headers, written through a separator.

4.4. File requirements for importing in XML

Files for importing payment instructions in XML format – text files with the *.xml extension in any encoding. These files must meet the following requirements:

- One file may contain several payment instructions separated by the following tags:
 - o < CURRENCY_PAYMENT > tag to indicate the beginning of the document,
 - CURRENCY_PAYMENT > tag to indicate the end of the document;
- Encoding information should be contained in the declaration of the xml file;
- Fields must be separated according to the rules of XML file generation;
- Optional fields may be left blank.

5. Import of currency documents on purchase, sale, exchange of foreign currency

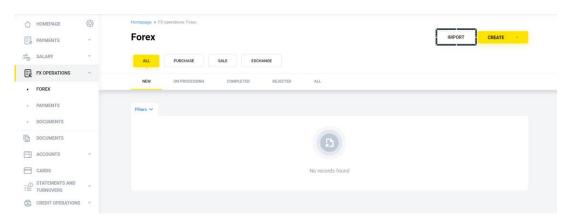
In Raiffeisen Business Online System, the user can import documents such as purchase, sale and currency exchange applications. You can import files in the following formats:

- TXT
- XML
- CSV

Requirements to the file structure depending on the format are described in subparagraphs 5.2-5.4.

5.1. Import of currency documents

To import currency documents, go to the menu section "Currency transactions" -> "Stock exchange transactions" and press



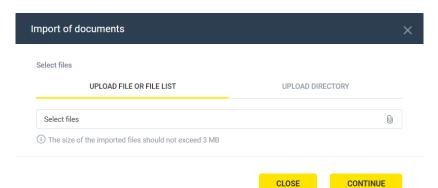
In the form that opens, you can import documents:





- By importing a single file or several files from a directory;
- By importing a directory that can contain several files.

To cancel the import of documents, press



To import, select the tab:

- "Upload file or list of files", or
- "Upload directory", press the button and select the required file/several files from the directory or directory with files, press continue. The System will perform the process of reading and checking for compliance with the format and structure of each file, as well as validating each individual document in the file.

After processing the files, the System will generate a report with the import results, which will indicate the number of successfully imported files and the number of files containing an error.

To view the details of the report on the import results of each individual document in the file, expand the list

on the form or download the report to your device by pressing

The following file import statuses are possible:

- Import completed successfully the file structure meets the requirements (see 1.2. -1.6.), all documents in the file were validated without errors;
- Import is partially completed the file structure meets the requirements (see 1.2. -1.6.), with at least one document in the file being validated without errors and at least one with an error;
- Import failed the file structure meets the requirements (see 5.2. 5.4.), all documents in the file have been validated with an error;
- File skipped the file structure does not meet the requirements (see 5.2. 5.4.).

To finish, press or DONE.

As a result, currency documents in the "New" status will be created in the System for all documents of the imported file or files, or for all files of the imported directory with the import status "Successful".

5.2. File requirements for importing in TXT

TXT format – text files with any extension in CP-1251 (Windows) encoding. A file of this format can have any name and extension.

- One file may contain several applications. Each subsequent document must follow the specified structure and be separated from the previous document by a blank line;
- Regardless of the number of documents in the file, the Content-Type=doc/ua_payment line must be present before the first record, followed by an empty line;
- Each line must consist of fields separated by a new line;
- Optional fields may be left blank.

5.3. File requirements for importing in XML

Files for importing currency documents in XML format – text files with the .xml extension. The file data must meet the following requirements:

- Each record of a currency purchase order must be tagged "<PURCHASE_REQUEST> </ PURCHASE_REQUEST>"
 tag.
- Each record of a currency sale request must be enclosed in the "<SALE_REQUEST> </ SALE_REQUEST>" tags.
- Each record of an order to sell currency must be tagged "<EXCHANGE_REQUEST> </EXCHANGE_REQUEST>"
- Each record of a currency conversion request must be tagged <INTRABANK_CURRENCY_PAYMENT></INTRABANK_CURRENCY_PAYMENT>.
- Each record of a SWIFT payment must be framed in <CURRENCY_PAYMENT></CURRENCY_PAYMENT> tags.

Notes:

- One file can contain several types of orders (purchase, sale, exchange) or several types of payments (intrabank or SWIFT)
- One imported file should not contain records of orders and payments together
- Optional fields may not be filled in:
 - o the value and header of the field are missing,
 - o the field header is present, but there is no value;
- The file structure can be specified by both attributes and tags

- One file can contain one or several currency documents separated by a blank line;
- Each line must consist of fields separated by the character ";"
- Optional fields can be left blank; in this case, empty parameter values will be listed with separators:
- It is possible to import files:
 - o With parameter values with headers
 - o With parameter values without headers, written through a separator.

If some fields have a header and some do not, the file will be ignored by the system and an error will occur.
